Reminders as to how we can show Love through our Leadership Skills There are numerous ways to show members how we can incorporate love, kindness and respect in our leadership role:

\*Interacting or communicating with others... Our tone of voice can play a huge role in how members will react to different situations.

\*Show members how much they are appreciated.... A handwritten thank you note, or phone call is more personal than an email. Go one step further and acknowledge members publicly.

\*Offer encouragement... If we see or learn that a new officer is struggling, offer kind words that will give them the boost they need.

\*Ask members how they are doing and really mean it... This will let members know we really care about them.

\*Offer support or help in time of need... Pray for members and ask what we can do to help.

\*Train rather than criticize... If a member is not meeting the assigned expectations offer support to include training.

\*Keep lines of communication open... Let members know that we are available to assist them at any time. Do not assume they know.

\* Out of respect... Let members know their opinion and suggestions counts. One may not like other's opinion or suggestion however, it is important to stay in a loving and accepting mode. This will let others know that we are approachable and that their opinion is appreciated.

\*Have a listening ear... Do not be in a position whereas we are doing all the talking. Give members the opportunity to express themselves. A good listener relates to not only hearing the speakers' words but also pays close attention to the non-verbal signals (gestures and body language) and reflects back to the speaker. Hearing is a physical ability and listening is a learned skill. Learn it. During our waking hours, we are communicating 80% of the time. At least 45% of that time we should be listening.

\*Show compassion...When a member is having a family issue or is just going through a rough time. Remember, we never know what a member is experiencing in their person life. If a member wants to share; just listen to what they have to say. There are times when members just need someone to listen.

\*Receive members unconditionally...Withhold judgment, welcome diversity of self-expression.

As we continue to grow in our leadership roles, we must constantly nourish the seeds of kindness, love and respect.

It is Time to "Fall Into" your Courts Standing Rules! Fall is my favorite time of year, as most of you know I live in the Central Valley of California which is an agriculture capital of the world. Fall is the time when all the hard work time energy and resources that our farmers and ranchers have put into their crops all year comes into recognition. From the buzz of the silage choppers to the parade of trucks loaded with almonds and other commodities heading down our country roads. The since of pride for being part of this vital process is all

around. You see it is not just the farmers who are proud of their crops but all the support business from the mechanics, water district employees, inspectors, consultants, and vendors who help support the process all come together in the Fall to witness the fruits of their labors. This is the time of year when all those involved not only harvest the fruits of their labors, but they plan for the next season to come.

Just like these Farmers in the Fall who now must work their fields to prepare for the Spring our CDA Courts need to use this time to prepare their Courts for the upcoming CDA Court Year. Most of you have been dark over the Summer and are meeting again planning your new calendars and budgets. But are your forgetting one of the most important tools of your Court? Your Courts Standing Rules. Most Courts have not had a review of the Standing Rules in, years or yes decades. Some Court leaders we have talked to did not even know if they had Standing Rules. Every Court in CA has had Standing Rules at some time in their court's history.

I would like to challenge every court officer to locate your Standing Rules and have your court look them over and update them this Fall. You should be able to find a copy of your courts Standing Rules in your court's historical minutes. Your need to go back over your court minutes to make sure that you are working from the most current copy.

To change your Standing Rules your will, need to have a meeting with your court to discuss the Standing Rules and have changes considered. Once that discussion has taken place the proposed updated Standing Rules need to be sent to all court members and your District Deputy, then at the next court meeting the Standing Rules need to be voted on. You cannot have any court Standing Rule that is contradictory to our CDA National Bylaws or Roberts Rulers of Order. If your need any help with this process, please reach out to your District Deputy. Once you have your Standing Rules updated your need to add the updated date to the official copy and send a copy to your District Deputy and make sure a copy is kept in the minutes when they were approved.

All officers should have an updated copy on them at every court meeting and event. Having your Standing Rules available at court meetings helps meetings going smoothly. No more one person in the audience insisting that "this is always done this way" without reason or proof. If all the officers have a copy of the courts Standing Rules, the court officers can confidently justify how they are conducting business and in a manner which reflects the "Will" of the entire Court not just one outspoken court member insisting on how things should be



done. This simple document will help your meetings run more professionally and more appealing to new and prospective members in attendance.

So "Happy Fall Ya' All" and it is time to "Fall into Your Standing Rules"

## PARLIAMENTARIAN

Greetings CDA sisters,

By now your meetings have been in full swing and you have been able to plan and hold events. Planning requires a bit of communication and control during meetings. As a new Regent (now a Past Regent), I often chuckled internally as I became familiar with using the GAVEL. It seemed so LOUD or too soft. Some

Regents use a "light tap," while others immediately enjoy the call to action with the "firm tap." Still, others get excited and "tap, tap, tap" as they try to control the room.

Robert's Rules of Order (RONR) addressed the proper use of this "Symbol of Authority" as:

- One tap After a vote [To instruct members to sit down] To adjourn the meeting.
- Two taps Call the meeting to order.
- Three taps "stand in union" such as when we salute the US Flag

It is acceptable to use a quick tap with a gavel followed by a polite "Order please" when too many

private side conversations are disrupting the flow of the meeting but use this sparingly.

Unacceptable use of the gavel: Gaveling through a vote/cutting off the rights of members to speak

or drowning out a disorderly member – either by voice or gavel.

Finally, did you know that if the Regent wishes to take part in debate, she can temporarily Pass the

Gavel? Deciding to do this requires some caution as the Regent is a facilitator who does not enter

into discussion or vote unless by ballot. <u>This enables the chair to maintain neutrality</u>. Ordinarily, the chair would pass the gavel to the Vice Regent unless she is also involved in the debate.

However, there are some circumstances where a chair should step down. Examples might be:

1) When the chair has a conflict of interest pertaining to the motion being considered.

2) When the motion being considered refers only to the chair in a capacity not shared with

other members, or that commends or censures him with others

3) When the chair wishes to take part in debate

See Robert's Rules of Order Newly Revised 12th edition 43:29 ) for more information.

Knowing how and when to use this "Symbol of Authority" will benefit both Regent and members in

understanding how and when to respond to each call to action during a meeting.





Courts will be awarded a Gold, Silver or Bronze standing in California. Many of our courts meet high standards already, but many go above and beyond and should be recognized.

The period being measured is from September to June. Points are awarded for the New Officer List and Officer Training in the even years when elections are held.

The Regent and DD should complete the form on page 2 and submit by June 30th to the California First Vice State Regent. Winning courts will receive a certificate and ribbon in July and winners will be announced in the Fall issue of Golden State Tidings. The ribbon may be hung from your banner standard (pole).

Below are the areas of assessment:

#### Administrative Procedures-Required by all courts

All courts must meet the minimum administrative functions such as electing new officers, completing required forms, paying dues and completing financial reviews.

#### Recruitment/Retention

The courts will have a growth plan that includes membership drives that serves the diversity in their communities and will have plans for retaining members through inclusiveness.

#### Spiritual

Courts will meet the CDA purpose of providing avenues of Spirituality for their members and will be recognized for maintaining an open line of communication with their Chaplain/Spiritual Advisor.

#### Communication/Collaboration

The courts will identify the avenues of communication they use to promote CDA, maintain communication with the State court and promote unity through sisterhood.
